WHAT WE DO

The full Governing Board meet on a regular basis, usually a minimum of once a term. In between these meetings, Governors also undertake a closer look at a particular aspect of the school's work, linked to their Strategic Role. Governors aim to visit the school once a term during the day, linked to their area of responsibility and at events such as Family Consultation Evenings. We also represent the school at a variety of functions and meetings.

Once a year Governors hold a 'Strategy Day' with all governors spending a whole day on site focusing on various aspects of the school. Along with this Governors regularly attend formal training organised by Herts. Governance to ensure we can fulfil our duties effectively.

We also review our own performance as a Governing Board to assess our skills and identify where we need to develop. The Governing group have a broad range of skills and experience. Allocated roles (called link roles) enable us to support and challenge school performance in a given area and strengthen and deepen our understanding of the impact of the school's work, its strengths and next steps.

LAST GOVERNORS BOARD MEETING AND PLANNING FOR 2023

In December we had a really productive meeting to close the year, taking the opportunity to reflect on 2022 and start plan for 2023. With new Governors joining it also seemed a good point to pause and reflect how the board works, our skills, training requirements and what we would like to do more of. As an action from this we have completed a skills audit and we're also looking at ways to be more visible to Parents and Carers – the first one being this Update! For 2023, meetings have been formalised and placed in the diary. Governors are currently liaising with school staff to agree timings for Spring Link Role school visits to deep dive into our areas of focus.

2022 saw significant change across the Governing Board with several new Governors joining whilst we also said goodbye to others. The Board has grown in size overall but we still have a number of vacancies to fill in our Parent Governor and Co-opted Governor positions. Recruitment on these voluntary positions is underway and if this is something you maybe interested in then please contact us via the school office.

Finance is also a critical area, particularly at a time where costs are increasing. Every pound needs to be spent wisely; best value principles at the heart of our decision making. Some great investments were made in 2022, including renovation of the bathroom facilities. In 2023, we have a separate Budget sub-committee working with the School Business Manager to understand the current plan as we continue to invest in Infrastructure.
