HOBLETTS MANOR JUNIOR SCHOOL ACCESSIBILITY PLAN

The DDA, as amended by the SEN and Disability Act 2001, places a duty on all schools to plan to increase over time the accessibility of their schools for disabled pupils and to implement their plans. This document details the plan for our school.

Statutory Responsibilities

As a school, we are required to plan for:

• increasing access for disabled pupils to the school curriculum.

This covers teaching, learning, and the wider curriculum of the school such as participation in after-school clubs, leisure and cultural activities or school visits. • improving access to the physical environment of schools.

This covers improvements to the physical environment of the school and physical aids to access education.

• improving the delivery of written information to disabled pupils.

This will include planning to make written information that is normally provided by the school to its pupils available to disabled pupils. Examples might include handouts, timetables, textbooks and information about school events. The information should take account of pupils' disabilities and pupils' and parents' preferred formats and be made available within a reasonable time frame.

Definition of Disability

A person has a disability if he or she has a physical or mental impairment that has a substantial and long-term adverse effect on his or her ability to carry out normal day-today activities.
